I am writing this update towards the end of another busy year for the charity, during which the substantial gap between need and provision continues to widen, reaffirming the important role played by funders working within Southwark, and those who support them,

Charterhouse in Southwark's ties to its local community have taken many guises since it was founded in the late nineteenth century. Although we no longer operate facilities, we support a range of organisations all across Southwark, enabling them to provide activities for children and young people that raise esteem, provide ambition and create a sense of achievement. Being a grant making organisation enables us to be flexible in our support, sometimes working with more established organisations whilst also donating to more recently established groups to enable them to get a start. During the current period, we have continued to support organisations we know well, such as London Community Boxing and formed new relationships, including Spring Community Hub and Free to Be Kids, featured in the newsletter.

To allow us to give this support, we rely upon the generosity of our donors, mostly Old Carthusians, who help to fund our programme of grant making. The trustee board would like to thank everyone who was donated funds during the year. We are particularly grateful to a former trustee whose generous donation once again covered the salary of our only employee.

For a number of years, Charterhouse in Southwark has contributed towards a bursary which allows a young person from the Borough to study at Charterhouse. Most recently Nabila Daboh completed her sixth-form studies at the end of the previous academic year and is now studying medicine at Lancaster. We wish her all the best and look forward to remaining in contact with her. Although we are not currently

Whilst the year ending 31 March 2023 saw a continued recovery from the effects of the Covid-19 pandemic and an apparent return to normality in many aspects of life, many of the people and communities we ultimate seek to serve continued to face many pressures. Our continued prudent approach to both investments and reserves again help facilitate the award of many grants to a wide variety of organisations.
