TREASURER'S REPORT

For only the second time ever, during 2017/18 Charterhouse in Southwark made over £100,000 in awards, to 12 different organisations. As a result of hard work in improving contacts in the Southwark area, we have successfully identified a number of new organisations to work with. We believe this has helped strengthen our core objective to support as a wide a number and as wide a range of young people in the London Borough of Southwark and its near environs.

We continue to monitor the efficiency and cost base of the charity. In the interests of good governance and as part of our ongoing internal monitoring of costs we decided to change auditors for the year ended 31 March 2018, resulting in the appointment of Field Sullivan LLP.

The support from regular donors remains absolutely critical to us and the Trustees are incredibly grateful for this. For the fourth year running, we have also been generously helped by a Trustee funding the costs of employing our part time employee. As in previous years, this means a very high proportion of income is available and used for charitable activities.

It has been a very rewarding year for Charterhouse in Southwark and I have been delighted to be part of it. The fresh identity of CiS has helped the charity become more recognisable which in turn has enabled us to be a supportive presence in Southwark. Our purpose remains the same; to fund charities that value and help young people develop emotional and social competencies, whilst creating an awareness of positive identity and aspirations.

With this in mind the Trustees and myself are always impressed by the terrific commitment from the non-profit organisations and the impact they make. All too often opportunities open to young people are dictated by socio-economic background rather than talent, potential or work ethic and whilst budgets for local services get thinner there is less help available for young people to access. The following is a list of charities or projects that have benefited from the generous funding from our donors and fundraising. BEDE HOUSE



Growing up in Bermondsey and Rotherhithe can be tough, with many families experiencing financial hardship and other pressures.

Bede House sits in the heart of this part of Southwark and for the second year running CiS has helped to fund Bede's Youth Adventure Project. They achieve their aims through a programme of evening clubs, detached youth work on local estates, residential stays, day trips and activities during school holidays, and providing awareness raising sessions in schools about "dating violence" in teenage relationships. It also provides practical and emotional help to young people at times of difficulty at home, at school, or with gang related issues. The Youth Club has a music studio and a bike repair workshop, both of which are very popular, and has developed volunteering and youth work training opportunities for those in their late teens and early 20s. Bede House is open for 44 weeks of the year and in 2017/18 worked with 369 young people.

2017/2018 GRANT BREAKDOWN

To honour our relationship with the Charterhouse school, we offer a biennial scholarship to a child from Southwark to attend Sixth Form.
